

Driver and Counter area (7)



- Once per year mandatory (incl. test)
- Confirmation has to be carried along always
- Needed time: approx. 5-10 minutes

Dangerous goods checks

Gate keeper counter (8)

Opening hours gate keeper:
Mo-Fr: **05:00 – 20:00** hours

Upon request additionally sale of

- Personal protective equipment (e.g. helmets, glasses),
- Equipment for Dangerous Goods Transports
- Load securing equipment... (as per available stocks)

Attention:

- Please mind the possible times for the delivery as mentioned in the order!
- Also for inbound deliveries: safety training is mandatory!



Required for the **Dangerous Goods Checks:** general drivers licence and ADR driver's license, car licence, Tremcards (ADR instructions in writing), fire extinguisher + other equipment required in the Tremcard

Truck parking

Short stay parking for trucks (3)

Compliance with waiting and parking restrictions

- The available space for short-stay parking for trucks is limited and intended exclusively for the time required (30 minutes max.) for the execution of the registration and check-in process.
- We want to highlight explicitly that it is **strictly forbidden to park vehicles at the Chemical Park over night or in order to take the weekly/daily rest period.**
- Any possible request to leave the short-stay parking, are to be followed!

Main entrance

Center lane (4)

Opening hours main entrance:
Mo-Fr: **06:00 – 19:00** hours

- Only with valid safety training certificate, complete personal protective equipment and required (un-)loading documents

Entrance for holders of permanent access badges

Fast lane (5)

Opening hours Fast lane:
Mo-Fr: **05:00 – 20:00**** hours

**After 20:00 hours please use the available intercom. (Wait until the roller gate has opened completely!)

- Only for holders of permanent access badges / “fast lane cards“
- Only for reliable and diligent drivers, with sufficient knowledge of the location and processes.
- Only with valid safety training certificate, complete personal protective equipment
- Permanent access cards are personalized and may not be passed on!

Weighbridge

Immediately after the entrance (10)



- Needs to be used upon request
- For holders of fast lane cards for LAT Nitrogen, it is possible to use the weighbridge prior to check-in at the auto-dispatch system

Exit

Exit lane (6)

- Only, if the required documentation is available
- Please then leave the premises of the Chemical Park immediately.
